Water Chemistry and Isotope Data Points are added if water sample results indicate detectable levels of nitrates or nitrites, volatile organic chemicals (solvents, fuel components), and/or synthetic organic chemicals (pesticides or herbicides). Tritium monitoring is included as a voluntary means of age-dating water. Generally, the older the water, the more protected the source. Point Range 0-50.
