What is SWAS? The Source Water Assessment Score (SWAS) is a process that factors geologic and water well attributes, water chemistry, and the potential contaminant sources for each drinking water source into a ranking system to determine the relative potential for contamination. Generally, sources with lower scores are considered to be less susceptible to contamination than sources with higher scores. However, exceptions do exist. This assessment is required by the Michigan Source Water Assessment Program (SWAP) under the provisions of the 1996 amendments to the Federal Safe Drinking Water Act. Well Log and Location A well log is a legal document describing the well location, construction, depth, soil formations penetrated, and capacity. Drilling contractors have been required to complete a well log and submit it to the owner, local health department, and State since 1967. The lack of information from a well log may increase the SWAS. Wellogic is an electronic database for well log information.
