| The Source Water Assessment Score (SWAS) is a process that factors geologic and water well attributes, water chemistry, and the potential contaminant sources for each drinking water source into a ranking system to determine the relative potential for contamination. Generally, sources with lower scores are considered to be less susceptible to contamination than sources with higher scores. However, exceptions do exist. This assessment is required by the Michigan Source Water Assessment Program (SWAP) under the provisions of the 1996 amendments to the Federal Safe Drinking Water Act. | | Contact |
