The Source Water Assessment Score (SWAS) is a process that factors geologic and water well attributes, water chemistry, and the potential contaminant sources for each drinking water source into a ranking system to determine the relative potential for contamination. Generally, sources with lower scores are considered to be less susceptible to contamination than sources with higher scores. However, exceptions do exist. A well log is a legal document describing the well location, construction, depth, soil formations penetrated, and capacity. Drilling contractors have been required to complete a well log and submit it to the owner, local health department, and State since 1967. Water Chemistry and Isotope Data Points are added if water sample results indicate detectable levels of nitrates or nitrites, volatile organic chemicals (solvents, fuel components), and/or synthetic organic chemicals (pesticides or herbicides). Tritium monitoring is included as a voluntary means of age-dating water. Generally, the older the water, the more protected the source. Point Range 0-50. (50 points = MCL violation) Susceptibility is Very High if contaminants exceed the Maximum Contaminant Level (MCL).
